Subject:- Grant of Conditional Permission to the Shiv Shakti Ayurvedic Medical College, Sunam Road Bhikhi, Mansa, Punjab (Inst. ID. AYU0333) for conducting 60 seats in UG (BAMS) course under section 28 of NCISM Act, 2020 and relevant regulations thereunder for the academic session 2021-22 -reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) has been dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government notified that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021. In view of the above the Central Government constituted the Autonomous Boards with effect from 11th June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine Act, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable:-

1. However, GOI, Ministry of AYUSH vide its letter no. L.14011/3/2020-EP (1) dated 26.03.2021 and 15.04.2021 issued Relaxation/support policy for ASU&S colleges in unprecedented times of COVID-19 pandemic for the academic session 2021-22 and the permission for the academic year 2021-22 of the ASU&S colleges will be considered on the basis of part-I visitation proforma submitted by the college provided that the college shall submit an undertaking & indemnity bond, stating that they shall fulfill respective requirements in terms of required teaching and training facilities specified in the relevant regulations throughout the academic year". Further, as per point no 'P' of above said relaxation policy and as per direction of President, Medical Assessment and Rating Board for Indian System of Medicine, random virtual visitation of your college was conducted on dated 08.10.2021.
2. Further, in view of above, the college has been assessed on the basis of concerned regulation and Relaxation policy issued by the Ministry of AYUSH and as per the visitation reports submitted by the visitor. On examining in terms of regulation 3 of "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020 and relevant regulations thereunder and as per the visitors report it was found that the College is not fulfilling the following notified and approved criteria for Grant of Conditional Permission for UG (BAMS) course for A.Y. 2021-22.

Shortcomings Mentioned in the visitation report as submitted by the visitors:-

1. OPD's, IPD's and OT are non functional.

Therefore, to follow the principle of natural justice as mentioned in the Constitution of India an opportunity of hearing was granted to your college on **11.11.2021** to present the case through virtual mode.
