**Subject- Regularization of Admissions made by Shiv Shakti Ayurvedic Medical College, Sunam Road Bikhi, Mansa, Punjab with 60 seats in UG (BAMS) course during the A.Y 2015-2016 and 2016-2017, passed by the Hon'ble High Court of Punjab & Haryana at Chandigarh in C.W.P No. 24136 of 2015 and C.W.P No. 4391 of 2017 and in reference of letter received from Ministry of AYUSH vide ref. no. L-11012/1/2022-EP-1 dated 20.07.2022 -reg**

Sir/Madam,

I am directed to refer to the Ministry's order dated 27.10.2015 & 09.12.2016 vide which denied permission under Section 13C/13A of the IMCC Act, 1970 was conveyed to the said college to take admission for 60 seats in UG (BAMS) course with for the A.Y. 2015-2016 & 2016-2017 due to not fulfillment of the basic requirement as per sub-Regulation 3 of Regulation 3 of RMS-2016 for granting conditional permission for 60 seats in UG (BAMS) course for the academic session 2015-2016 and 2016-2017 respectively.

In view of above decision, the College has challenged the Ministry's denial order dated 27.10.2015 for the A.Y. 2015-2016 and approached before the Hon'ble High Court of Punjab & Haryana at Chandigarh and filed writ petition no. 24136 of 2015. The Hon'ble High court of Punjab & Haryana, vide its order dated 31.10.2017 disposed of the writ petition no. 24136 of 2015 and directed as under:-

**"since the students admitted pursuant to the interim orders passed by this Court, referred to in the earlier part of this order, are already pursuing their course from the last about two years and the petitioner institute has already removed the deficiencies, we are satisfied that the admission made by the petitioner-institute in the Academic session 2015-1016 deserves to be regularized. "**

Similarly, the college has challenged the Ministry's denial order dated 09.12.2016 for the Academic 2016-2017 and approached before the Hon'ble High Court of Punjab & Haryana at Chandigarh and filed Writ Petition no. 4391 of 2017. The Hon'ble High court of Punjab & Haryana, vide its order dated 13.11.2017 disposed of the writ petition no. 4391 of 2017 and directed as under:-

**"In view of the fact that the petitioner has been found to have removed the deficiencies and in the absence of any short coming, UOI has granted permission to admit students for the session 2017-18, coupled with the fact that the students admitted by the petitioner for the session 2016-17 have spent an year in pursuing the course, and also for the reasons assigned by us in our order dated 31.10.2017, passed in CWP No.24136 of 2015, the instant writ petition stands allowed. The impugned order is modified and the admissions made by the petitioner- Instituted in the A.Y session 2016-17 are ordered to be regularized".**

Further, Medical Assessment and Rating Board is also in receipt of letter from M/O AYUSH vide ref. no L-11012/1/2022-EP-1 dated 20.07.2022 forwarding the order dated. 31.10.2017 & 13.11.2017 passed by the Hon'ble High Court of Punjab & Haryana at Chandigarh in C.W.P No. 24136 of 2015 and C.W.P No. 4391 of 2017 for regularization of Admissions made by Shiv Shakti Ayurvedic Medical College, Sunam Road Bikhi, Mansa, Punjab with 60 seats in UG (BAMS) course during the A.Y 2015-2016 and 2016-2017 in compliance of Court Order.

Therefore, as mentioned above, in compliance of above said order passed by the Hon'ble High Court of Punjab & Haryana at Chandigarh in C.W.P No. 24136 of 2015 and C.W.P No. 4391 of 2017, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine

(NCISM) to regularize admissions made by Shiv Shakti Ayurvedic Medical College, Sunam Road Bikhi, Mansa, Punjab with 60 seats in UG (BAMS) course during the A.Y 2015-2016 and 2016-2017.

The earlier order of Ministry's order dated 27.10.2015 & 09.12.2016 as per the aforesaid court order stands withdrawn.
